ZERO TOLERANCE POLICY



Due to several incidents involving fans, coaches, players, parents, and off-ice officials, the Redhawks Hockey Association Board feels it is necessary to remind everyone that we fully support the "Zero Tolerance Policy". This policy has been set by USA Hockey and the Amateur Hockey Association of Illinois (AHAII).

"A minor penalty for unsportsmanlike conduct (zero tolerance) shall be assessed whenever a Player, Coach, Fan or Off-Ice Official:

- 1. Openly disputes or argues any decision by an official.***
- 2. Uses obscene or vulgar language in a boisterous manner to anyone at any time.***
- 3. Visually displays any sign of dissatisfaction with an official's decision, including standing on the boards or standing in the bench doorway with the intent of inciting the officials, players, or spectators. Any time a coach persists in any of these actions (s) he shall be assessed a game misconduct penalty.***

Parents can also be suspended from attending their child's games. This form must be signed by the parent/guardian and returned prior to the first game.

Redhawks Hockey Association Player Code of Conduct for the 2010-2011 Season



Due to several incidents involving fans, coaches, players, parents, and off-ice officials, the Redhawks Hockey Association Board feels it is necessary to remind everyone that we fully support the "Participant Code of Conduct" which has been set by USA Hockey.

1. No swearing or abusive language on the bench, in the rink or at any team function.
2. No lashing out at any official no matter what the call is. The coaching staff will handle all matters pertaining to officiating.
3. Anyone who receives a penalty will skate directly to the penalty box.
4. Fighting will not be tolerated. Fighting will result in an appearance before the Rules & Ethics Committee.
5. There will be no drinking, smoking, chewing of tobacco or use of illegal substance at any team function.
6. I will conduct myself in a befitting manner at all facilities (ice rink, hotel, restaurant, etc.) during all team functions.
7. I will arrive 60 minutes prior to each game and will be ready 10 minutes before practice.
8. I will call my coach before I miss any practice or game.
9. I will dress appropriately for arrival at all games (as directed by the coach)

Any player or team official who cannot abide by these rules or violates them will be subject to further disciplinary action including possible expulsion from Redhawks Hockey).

The NCHS Redhawks Hockey team also supports a Zero Tolerance policy towards Game Misconduct behavior by any of our players. The consequences for this behavior will be addressed as outlined below:

- 1) One game Misconduct (ejection from game) will result in appropriate AHAI ruling and suspension with an RHA Warning.
- 2) A second game Misconduct will result in appropriate AHAI ruling and suspension and a 3 game suspension by RHA.
- 3) A third game Misconduct will result in appropriate AHAI ruling and suspension and a 1 month full suspension by RHA.
- 4) A fourth game Misconduct will result in appropriate AHAI ruling and suspension and will be subject to team expulsion by RHA.
